

- D. **Aadhar based eSignature or eSign** is an Aadhaar authentication based digital signature via **NSDL** which can be performed using the Aadhaar OTP or Aadhaar Biometric verification method. For Aadhaar biometric, you need to procure a Aadhaar registered Biometric Device.
- E. **Hardware Security Module (HSM)** is one of the forward-looking computing devices, responsible to manage the authentication, encryption, decryption, transaction signing, under a secured environment. HSM based solution is recommended for Financial or Utility bill based activities, where volume to digitally sign documents is very high. Client has to procure HSM device, and configuration is according to client's business requirements.
